In order for students to earn an Early Childhood Preschool Certificate, the following courses must be taken: EDU 119, EDU 131, EDU 145, EDU 146, and EDU 153. (See the Early Childhood Preschool (C55860) Program Completion Guide.)

In order for students to earn an Infant/Toddler Care Certificate, the following courses must be taken: EDU 119, EDU 131, EDU 144, EDU 153, and EDU 234. (See Infant/Toddler Care (C55290) Program Completion Guide.)

In order for students to earn a **School-Age Care Certificate**, the following courses must be taken: EDU 131, EDU 145, EDU 146 or EDU 163, EDU 158, EDU 235, and EDU 263. (See **School-Age Care (C55450)** Program Completion Guide.)

Students enrolled in EDU 284, wishing to complete hours outside of Richmond county and Scotland county North Carolina must complete practicum hours at a location meeting one of the following criteria: NAEYC accredited; a Public School Pre-K-3<sup>rd</sup> grade; Head Start or Early Head Start; or NACCRA accredited. The student must be directly supervised by an individual holding an associate degree or higher in Early Childhood Education or related program.

EDU 114 and EDU 119 have components of the course using the North Carolina Foundations for Early Learning and Development, which is a free resource.
