COURSE: EMS 131 ADVANCED AIRWAY MANAGEMENT

HOURS: Lecture: 1 Lab/Shop: 2 Work Exp/Clinical: 0 Credits: 2

COURSE DESCRIPTION:

This course is designed to provide advanced airway management techniques and is required for paramedic certification. Topics must meet current guidelines for advanced airway management in the pre-hospital setting. Upon completion, students should be able to properly utilize all airway adjuncts and pharmacology associated with airway control and maintenance.

STUDENT LEARNING OUTCOMES:

At the completion of the course, the students should be able to demonstrate satisfactory progress by earning a grade of 70% or higher on the final written exam and by successfully applying knowledge of the course content in a practical exam of patient care scenarios, which will be evaluated using National Registry standards.

Upon successful completion of this course, the student will be able to:

- 1. Describe the major structures and physiology of the respiratory system, including the upper and lower airway
- 2. Discuss important concepts related to ventilation, including partial pressure, volumes, and neural and chemical control of ventilation.
- 3. Explain positive-pressure ventilation versus negative-pressure ventilation.
- 4. Discuss acid/base imbalance, specifically respiratory acidosis and respiratory alkalosis.
- 5. At the end of this course the student will be able to list the signs of adequate breathing and inadequate breathing
- 6. List abnormal breathing patterns to recognize when assessing a patient is breathing.
- 7. Discuss how to assess a patient's breath sounds.
- 8. Describe the assessment and care of a patient with apnea.
- 9. Understand how to assess for adequate and inadequate respiration, including the use of pulse oximetry.
- 10. Understand the importance and techniques of suctioning.
- 11. Demonstrate the use of BLS airway techniques such as the NPA, the OPA, and BIAD

- 12. Describe the use of a one-, two-, or three-person bag-mask device and a manually triggered ventilation (MTV) device.
- 13. Describe the indications, contraindications, and complications of use of continuous positive airway pressure (CPAP).
- 14. Discuss airway management considerations for patients with a laryngectomy, tracheostomy, or stoma.
- 15. List the advanced airway devices and techniques available to the paramedic.
- 16. Comprehensively discuss methods used to predict the difficult airway.
- 17. At the end of this course the student will be able to describe the advantages, disadvantages, and equipment used when performing endotracheal intubation. Comprehensively discuss the indications, contraindications, advantages, disadvantages, and complications of orotracheal intubation.
- 18. Comprehensively discuss the methods available for confirming correct endotracheal tube placement and the advantages and disadvantages of each method.
- 19. Comprehensively discuss the indications, contraindications, advantages, disadvantages, and complications of nasotracheal intubation.
- 20. Comprehensively discuss the indications, contraindications, advantages, disadvantages, and complications of digital intubation.
- 21. Comprehensively discuss the indications, contraindications, advantages, disadvantages, and complications of transillumination intubation.
- 22. Comprehensively discuss how to perform tracheobronchial suctioning.
- 23. Comprehensively discuss considerations related to field extubation.
- 24. Comprehensively discuss the indications, contraindications, advantages, disadvantages, and complications of endotracheal intubation in the pediatric patient.
- 25. List possible pharmacologic adjuncts to airway management and ventilation, including both sedatives and neuromuscular blocking agents used for emergency intubation.
- 26. Comprehensively discuss the procedure for performing rapid-sequence intubation (RSI).
- 27. Comprehensively discuss blind insertion airway devices (BIAD) including the combitube, COBRA, LMA, Igel. and King LST.
- 28. Comprehensively discuss the indications, contraindications, advantages, disadvantages, and complications of performing needle cricothyrotomy.

EXPLANATION OF SYLLABUS:

The Student Learning Outcomes listed in this syllabus are those required actions that a student who successfully completes the course must be able to perform or exhibit. The educational experience, however, is a two-way, interactive process involving both the student and his/her instructor. The student must play an active role in the learning process in order to be successful. Each Instructor will provide an Instructor's Course Requirements document at the first class meeting explaining how he/she measures each of the Student Learning Outcomes listed in the syllabus. A student who is unable to accomplish the outcomes will not receive a passing grade in the course.

The information in this RCC Syllabus may not be accurate beyond the current semester. Textbooks and other course materials are subject to change. Students should verify the textbooks at the first class meeting with their instructor prior to purchasing.

RCC ATTENDANCE POLICY:

Regular attendance is considered essential to realize course outcomes. Rules on attendance, tardiness, and leaving class early are addressed in each Instructor's Course Requirements document.

No matter the basis for absence, students are held accountable for academic activities, and faculty may require special work or tests to make up for missed classes.

When courses are delivered through online instruction (DL or Distance Learning) or through a combination of traditional classroom and online instruction (hybrid), class participation is no less important, though its measurement may be somewhat different.

The Nursing Department's requirement related to attendance exceeds the college policy. Nursing students are required to attend 90% of classes, labs, and clinicals. At the discretion of the instructor, a written assignment or makeup clinical may be given for hours missed determined to be unavoidable.

RCC GRADING SYSTEM:

Richmond Community College employs a system of letter grades and corresponding quality points per grade to evaluate a student's performance in meeting the stated goals and objectives for each course.**

SECURITY AND SAFETY PROCEDURES:

RCC's upgraded security procedures require all doors to be locked at class start-time.

WITHDRAWAL:**

Students may withdraw from Richmond Community College curriculum courses up to the published Last Date to Withdraw (90% point of the section term). The student will receive a grade of "W" for the class and will not receive credit for the course. The "W" grade will not be used to compute hours earned or to compute the student's grade point average. If the student presents written documentation of extenuating circumstances which make it impossible to continue in the course

after the 90% point, a late withdrawal (occurring after the published Last Date to Withdraw and on or before the last date of the section term) may be approved. A late withdrawal must be approved by the Vice President of Instruction.

In order to formally withdraw from a course, the student must complete a Student Initiated Withdrawal Form. The student is encouraged to read through the refund policies, and discuss the impact of withdrawing with their instructor, advisor, financial aid staff, and/or Veterans' Coordinator.

Individual instructors may have attendance requirements in individual classes. The instructor will notify the student if they are at risk of being withdrawn from an individual course due to the attendance requirements outlined on the Instructor's Course Requirements for an individual course. The instructor will notify the student's advisor and the Veterans' Coordinator if an instructor initiated withdrawal is imminent for courses that have an attendance policy. Instructors not having a course specific attendance policy are not allowed to withdraw students due to attendance.

A withdrawal occurring before the 10% census reporting period ends for that course will not be included on the student's transcript. This is considered dropping a course.

Depending upon what point in the semester the student withdraws from a course, financial consequences may occur for the student if they are receiving any form of financial aid, scholarships, and/or veterans benefits.
