Methodology Regarding CRRSSA/HEERF II/HEERF III/ARP March 10, 2022 Disbursement

Richmond Community College acknowledges that it signed and returned to the Department of Education the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students. The College has received a total of \$5,463,109 for this purpose. Including this disbursement, the College has awarded a total of \$5,463,109 at this time.

The Leadership Team of RichmondCC decided in August 2021 that another disbursement of CRRSSA/HEERF II/HEERF III/ARP student funds needed to be made and worked together to decide on the criteria and timing for the award. Once again, exceptional need was taken into account and a list was generated that contained all currently enrolled (as of February 28, 2022) non-high school curriculum students, which totaled 1,181 students. The list also contained the student's currently enrolled hours (as of 2/28/2022) for Spring 2022, as well as their Expected Family Contribution (EFC), as calculated from their FAFSA. Based on this list and further discussions, it was decided that students with an EFC from 0 to 5846 (threshold for Pell eligibility) would qualify for the full funding on a sliding scale based on their hourly load. For students with an EFC above 5846, or if they had no EFC on file, the student would qualify for 50% of the original amount, based on load. Students that had an EFC of 0 - 5846 would be eligible for up to \$1,000, depending on their load. Students that have an EFC above 5846 (or no EFC on file) would be eligible for up to \$500 depending on their load (see charts below). Total disbursement for this methodology was \$709,985.00.
